소개

Intertek 은 <mark>사우디 수출하는</mark> 중고 자동차를 검사하여 SASO 기술 규정의 요구사항을 충족하는지 확인하는 인증 기관으로 승인되었습니다. 이 인증은 사우디아라비아의 <mark>세관</mark> 통관에 필수적입니다.

인증 절차

인증 절차는 차량의 상태를 평가하고 모든 관련 규정을 준수하는지 확인하는 철저한 검사를 포함합니다. 차량이 사우디 기준에 충족하면 적합성 인증서(COI)가 발급됩니다.

수출 절차

바이어가 SABER 에 차량 정보를 입력하고 인터텍을 검사 회사로 지정 하세요.

인터텍이 지정한 차량 시험 센터에서 검사를 받으세요.

검사 결과가 적합한 경우 SABER 상에서 인터텍의 적합성 인증서 (COI)가 발급 됩니다.

바이어는 SABER 에서 비용을 지불하고 수출자는 인터텍에 비용을 지불 해야 합니다.

SASO INSPECTION PROGRAMME

EXPORTER AND IMPORTER GUIDELINESUSED MOTOR VEHICLES

OVERVIEW

Intertek has been appointed as an Inspection Body authorised to issue Certificates of Inspection (Cols) for Used Motor Vehicles to the Kingdom of Saudi Arabia (KSA).
This service offered by Intertek verifies the conformity of all 'Used Motor Vehicles' from the respective exporting countries and ensures that they comply with applicable SASO Technical Regulation (SASO TR).

The implementation of this programme would require all Used Motor Vehicles imported to Saudi Arabia to have Cols issued from the SABER platform for KSA Customs clearance. Exporters are requested to contact local Intertek Offices to understand and comply with the requirements of SASO to ensure uninterrupted export of their consignments of Used Motor Vehicles to KSA.

PRODUCT COMPLIANCE



Products requiring a Conformity Document

Obtaining SABER Certificates of Inspection (Cols) is mandatory for Used Motor Vehicles imported into KSA from anywhere in the

Exporters/Importers trading Used Motor Vehicles to the KSA need to demonstrate compliance with the requirements of the SASO TR MA 179-21-09-02 for Used Imported Vehicles.

SASO has advised that the requirements to obtain a SABER Col will be launched in two phases as below:

• Phase 1 - For Private Individuals

• Phase 2- For Commercial Entities
The enforcement dates for these phases will be announced by SASO shortly.

The compliance verification procedure will involve inspection of the Used Motor Vehicle by an approved Inspection Body such as Intertek to evaluate it's condition and check conformity with the SASO TR requirements. A Col will be issued by Intertek in SABER based on a successful inspection stating that the Used Motor Vehicle under certification is in conformity with the requirements of the SASO TR and inspection procedures prior to importing it into the KSA.

CERTIFICATION PROCESS

Exporter/Importer contacts Intertek Office or Importer raises a Certification request in SABER, provides all the details of the Used Motor Vehicle* (Vehicle information, photographs, VIN etc.) and pays the SABER registration fee.

Client approaches Intertek for Inspection and pays the Certification fee

Intertek performs Inspection of the Used Motor Vehicle

Intertek reviews the Inspection Reports

Issuance of Certificate of Inspection (CoI) by Intertek in SABER



*Note: One Col will be issued per Used Motor Vehicles. If there are more than one Used Motor Vehicles, then multiple Certification requests shall be raised in SABER.

CERTIFICATION PROCESS

Intertek can assist with the SABER registration process and the issuance of SABER Col for Used Motor Vehicles within the scope of the SASO TR, imported into the KSA from the following regions:

- Americas
- Middle East and North Africa (MENA)
- Europe
- Asia

All Used Motor Vehicles exported to the KSA are required to have SABER Cols in order to clear the consignments at KSA ports and borders.

FEES

The party applying to Intertek for inspection and certification services is responsible for the payment of charges to Intertek. In addition, SABER registration charges will also apply.
